


The Machinery Directive (MRL) describes uniform statutory health and safety requirements for the European Economic Area (EEA) that must be observed in the design and construction of machinery, partly completed machinery and products assimilated to machinery.

Which products are regulated in the MRL?

The MRL regulates the conditions under which the products listed below may be made available or put into service in the EEA:

- Machines
- Interchangeable equipment
- Safety components
- Load handling attachments
- Chains, ropes and belts
- Detachable cardan shafts
- Incomplete machine

Who must apply the MRL?

The MRL is addressed to the manufacturer who makes a product covered by the scope available in the EEA for the first time.

Due to the linking of (incomplete) machines with a higherlevel control system to form a system or due to modifications to machines or systems after they have been commissioned, in practice operators often also become so-called "own manufacturers".

Which requirements result from the MRL?

The manufacturer (or own manufacturer) must carry out a conformity assessment procedure as proof of compliance with the legal provisions before placing the product on the market or putting it into service. An essential component is the preparation of technical documentation, in particular the documents:

- Risk assessment
- Installation and operating instructions
- Declaration of Incorporation or EU/EC Declaration of Conformity

Does the MRL also apply to process plants?

In the practical application of the term "installation", the question often arises in the case of large industrial installations (e.g. power plants or installations in the chemical industry) as to what extent such installations are subject to the requirements of the MRL as a "set of machinery".

The guideline on the application of the MRL refers to this situation. The guide states that the definition of "assembly of machinery" does not have to be applied to a complete industrial installation in its entirety.

However, it is pointed out that these plants can usually be subdivided into individual functional units related to production and safety, such as raw material unloading and feeding as well as processing, packaging and loading units, for each of which the requirements of the MRL are to be applied.
